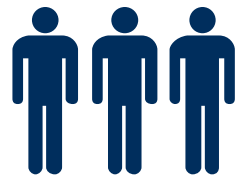

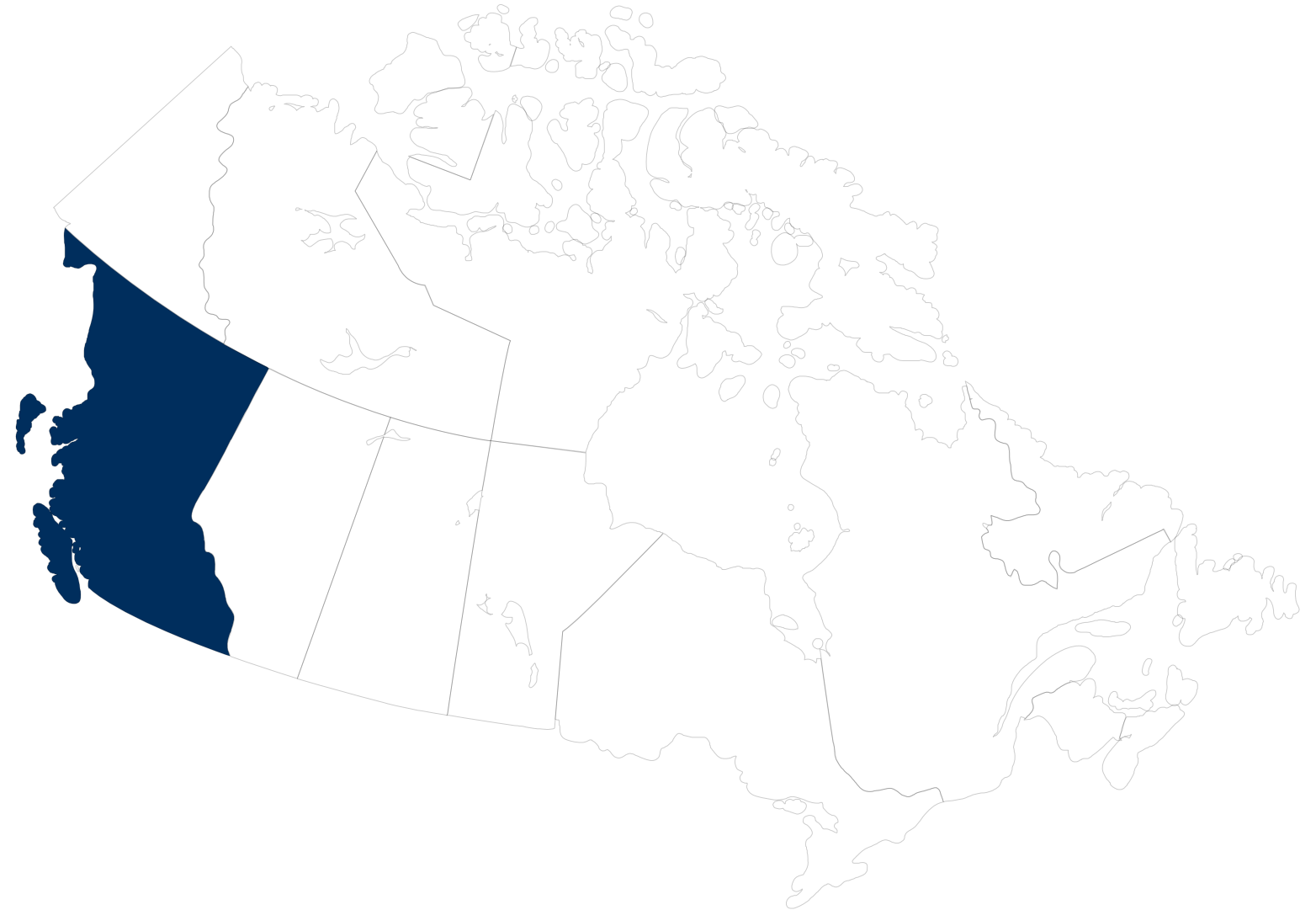

ON CAMPUS HOUSING

3rd year students will be placed in the lottery system. Meal plans available. \$1,326 single room, includes meal plan



HOMESTAY

Student placed with Canadian family who provides 3 meals a day and opportunity to learn the local lifestyle. Fees are \$900/month.



OFF CAMPUS HOUSING

Renting an apartment, basement suite or condo can range from \$300-\$1,200/month.

Minimum 65% in the required courses listed in agreement.

2. English language proficiency requirement:

- IELTS: 6.5 with no section less than 6.0 **OR**
- TOEFL: 90 (iBT) with no band less than 20

Students with IELTS 6.0 (each section 5.5) or TOEFL 79 (each section 17) may be offered conditional acceptance.

A four-week “University Admissions Preparation” course must be completed at UVic in August. Pass with 80%.

3. Supplemental Application

Overview

The supplemental application is an opportunity for you to introduce yourself to us. This is your chance to highlight any work, leadership, academic, volunteer and/or life experiences, and to reflect on how these experiences have allowed you to learn, develop and grow. We encourage you to use examples; whether those be in the classroom, in club or recreation activities, at work, through personal experiences or in community endeavours.

Reflect on who you are, what you've accomplished, and what your goals are. Where do you want to go, and how is Gustavson going to help you get there? The Gustavson BCom program is looking for dynamic and driven students who are eager to develop their global mindset, collaborate with others, and consciously work towards making a difference while developing their business acumen. If this sounds like you, we encourage you to apply! Keep these things in mind when answering the questions below.

Required components

1. Current resume

- Two pages maximum; only references may extend on to a third page.
- Please note that reference letters will not be considered in the admission process.

2. Personal statement: your background and motivation

What are the **three things** that you want us to know about you, and how will these contribute to your success in university and our BCom program?

- Please provide specific examples.
- Minimum 250 words in paragraph format.

3. Impact statement: your personal road map

Gustavson BCom students create a real impact in local and global communities. Please tell us: what impact do you intend to create, and how will the Gustavson BCom program help you to do this?

- Please provide specific examples.
- Minimum 200 words in paragraph format.

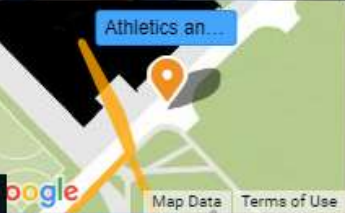
