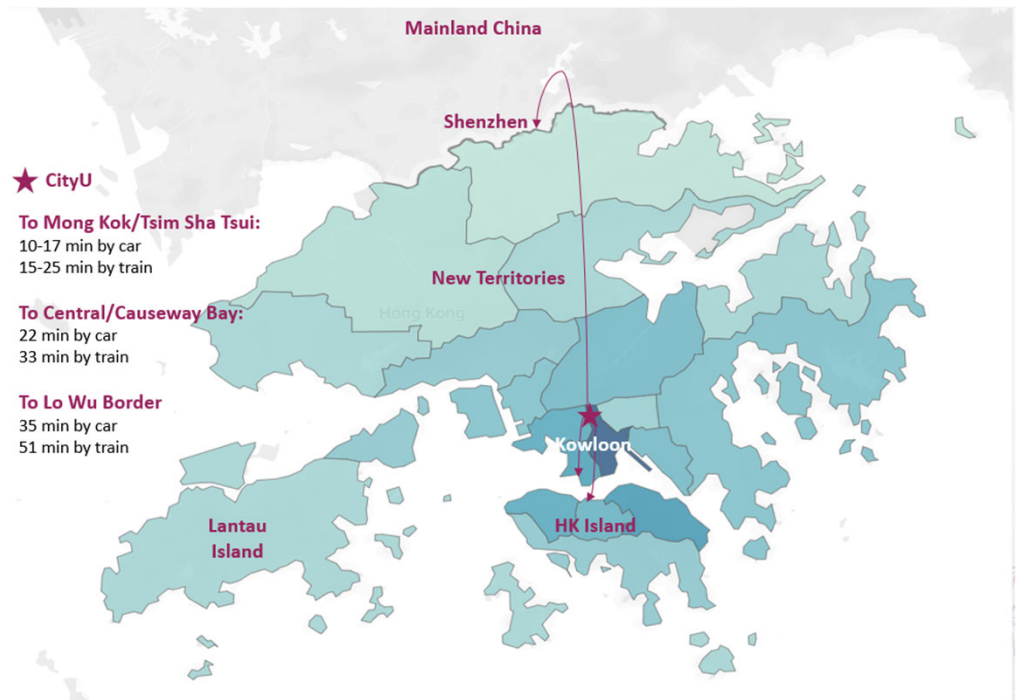

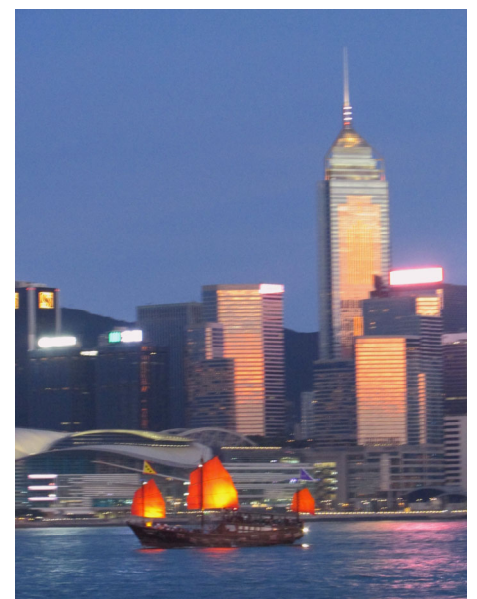

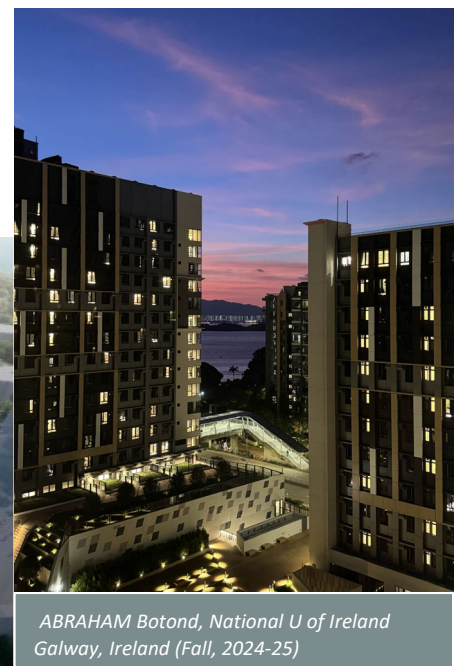
- Administrative Fee

## Course Enrolment

Postgraduate exchange students are expected to take courses at CityUHK in the following programme/disciplines of study, subject to availability of places and prerequisite requirements:

- Master of Business Administration (MBA)
- Accountancy
- Information Systems
- Management

- Marketing

Postgraduate exchange students are not allowed to take Bachelor degree level courses at CityUHK.

## Maximum and Minimum Credit-Unit Load

## Insurance >>>

It is mandatory for non-local students to have suitable and adequate insurance covering travel, personal accidents, medical expenses (accident and non-accident), hospitalization and emergency evacuation / repatriation throughout the entire period of their study in Hong Kong. Students are required to either purchase the insurance on their own before they leave their home city or, if they are unable to do so or wish to have additional insurance coverage, enroll in the Group Personal Accident and Medical Benefits Insurance Plan for Non-local Students contracted by CityUHK.

All exchange students are required to indicate their insurance enrolment decision during the online pre-enrolment process, whether they wish to enroll in the insurance plan or not.

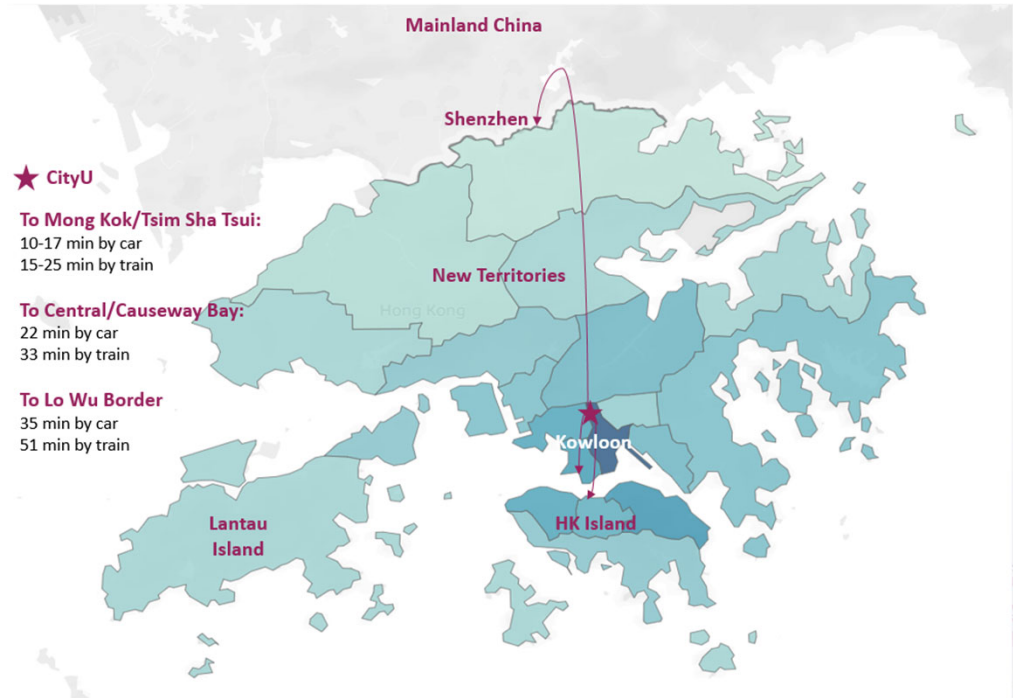

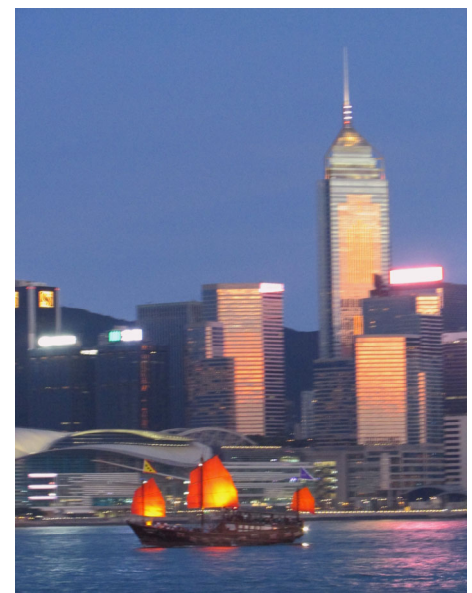

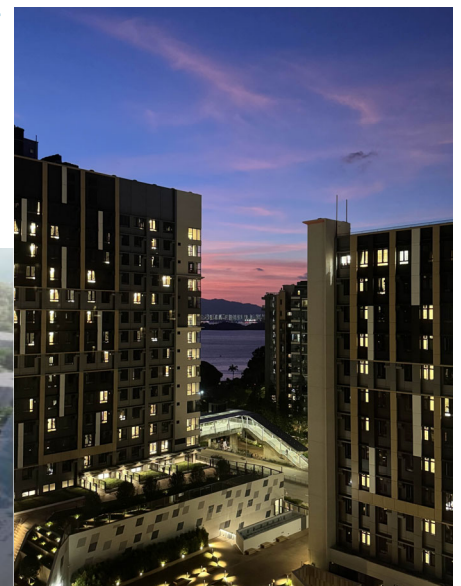
